Hot Chocolate

# Ingredients:

- · 3 cups confectioners' sugar, sifted
- · 2 cups unsweetened cocoa powder
- 12 cups whole milk
- 2 teaspoons pure vanilla extract
- 1 teaspoon kosher salt
- · 8 ounces dark chocolate, finely chopped
- · 24 peppermint candies, crushed (about 1 cup), for serving
- 3 cups mini marshmallows, for serving

# Directions:

- 1. Whisk together the sugar and cocoa powder in a 6-quart slow cooker. Turn the cooker to high, and slowly whisk in the milk to prevent lumps from forming. Add the vanilla and salt, cover and cook for 1 1/2 hours. The sugar and cocoa powder should be completely dissolved.
- 2. Whisk in the chopped chocolate a little at a time until it is all incorporated. Replace the lid, and cook until thickened, 30 minutes
- 3. Turn the cooker to warm, and serve with small bowls of the peppermint candies and mini marshmallows. For minty cocoa, let a few teaspoons of the peppermints melt in an 8-ounce cup.
